

### Aims and Scope

The *JBI Library of Systematic Reviews* is a fully refereed library that publishes systematic reviews of literature. These reviews may be of quantitative or qualitative research data, text and/or opinion, relate to economic data or combinations of the above.

The *JBI Library of Systematic Reviews* publishes systematic reviews undertaken by the Joanna Briggs Institute and its international collaborating centres and groups. However there is facility within the library for publication of systematic reviews undertaken by authors unrelated to the Joanna Briggs Institute.

### Submission of Manuscripts

Manuscripts should be submitted by uploading information at:

The entire article should be supplied as three files, the covering letter (provided as a word file not for review in keeping with the review process), a cover sheet (including names and contact details of the authors along with any acknowledgements to appear in the final review), and the manuscript (de-identified suitable for blind peer review). Electronic figures and tables should also be supplied as separate files.

All articles submitted to the *JBI Library of Systematic Reviews* must comply with these instructions. Failure to do so will result in return of the manuscript and possible delay in publication.

- Specify any special characters used to represent non-keyboard characters.
- Take care not to use l (ell) for 1 (one), O (capital o) for 0 (zero) or ß (German esszett) for (Greek beta). β
- Use a tab, not spaces, to separate data points in tables. If you use a table editor function, ensure that each data point is contained within a unique cell (i.e. do not use carriage returns within cells).

Graphics must be provided as separate, high resolution (at least 300 d.p.i.) files, saved as .eps or .tif. Digital images supplied only as low-resolution files cannot be used.

### Covering letter

Papers are accepted for publication in the library on the understanding that the content has not been published or submitted for publication elsewhere. This must be stated in the covering letter. The covering letter must also contain an acknowledgement that all authors have contributed significantly, and that all authors are in agreement with the content of the manuscript.

If tables or figures have been reproduced from another source, a letter from the copyright holder (usually the publisher), stating authorisation to reproduce the material, must be provided with the covering letter.

In keeping with the latest guidelines of the International Committee of Medical Journal Editors, each author's contribution to the paper is to be quantified.

Authors must state that the protocol for the research project has been approved by a suitably constituted Ethics Committee of the institution within which the work was undertaken and that it conforms to the provisions of the Declaration of Helsinki in 1995 (as revised in Edinburgh 2000).

All investigations on human subjects must include a statement that the subject gave informed consent. Patient anonymity should be preserved.

Any experiments involving animals must be demonstrated to be ethically acceptable and where relevant conform to national guidelines for animal usage in research.

Authors must declare any financial support or relationships that may pose conflict of interest.

### **Cover sheet**

The cover sheet should include a list of all authors, their qualifications and contact details. The 'Acknowledgements' should also be listed on this cover sheet, as these may lead to the paper being identifiable and are therefore not suitable to be sent to the peer reviewers.

### **Copyright**

Authors publishing in the library will be asked to sign an Exclusive Licence Form. In signing the Form it is assumed that authors have obtained permission to use any copyrighted or previously published material. All authors must read and agree to the conditions outlined in the Form, and must sign the Form or agree that the corresponding author can sign on their behalf. Articles cannot be published until a signed Form has been received. ### **Style**

Manuscripts must use Vancouver referencing. More information about the style of the Vancouver agreement is detailed in the International Committee of Medical Journal Editors' revised 'Uniform Requirements for Manuscripts Submitted to Biomedical Journals: Writing and Editing for Biomedical Publication', as presented at <http://www.ICMJE.org/>.

The library uses Australian spelling and authors should therefore follow the latest edition of the Macquarie Dictionary. Please write in a clear, concise, direct style. All measurements must be given in SI units. Abbreviations should be used sparingly; use only where they ease the reader's task by reducing repetition of long, technical terms. Initially use the word in full, followed by the abbreviation in parentheses. Thereafter use the abbreviation only.

Drugs should be referred to by their generic names. If proprietary drugs have been used in the study, refer to these by their generic name, mentioning the proprietary name, and the name and location of the manufacturer, in parentheses.

### **Acknowledgements**

The source of financial grants and other funding must be acknowledged, including a frank declaration of the authors' industrial links and affiliations. The contribution of colleagues or institutions should also be acknowledged. Personal thanks and thanks to anonymous reviewers are not appropriate. Please note that acknowledgements should be included in the cover sheet.

### **Parts of the manuscript**

Manuscripts should be presented in the following order: (i) title, (ii) abstract and keywords, (iii) text, (iv) references, (v) appendices, (vi) figure legends, (vii) tables (each table complete with title and footnotes) and (viii) figures. Footnotes to the text are not allowed and any such material should be incorporated into the text as parenthetical matter.

## **Title page**

As articles are double-blind reviewed, material that might identify authorship of the paper may be placed on a cover sheet; this will not be sent to referees.

The title should be short, informative and contain the major key words. Do not use abbreviations in the title. A short running title (less than 30 characters, including spaces) should also be provided.

## **Abstract and key words**

All articles must have a structured abstract that states in 500 words or fewer the purpose, basic procedures, main findings and principal conclusions of the review. The abstract may be divided with headings such as: Aim, Methods, Results, Conclusions. The abstract should not contain abbreviations or references.

Five key words, for the purposes of indexing, should be supplied below the abstract, in alphabetical order, and should be taken from those recommended by the US National Library of Medicine's Medical Subject Headings (MeSH) browser list: [www.nlm.nih.gov/mesh/meshhome.html](http://www.nlm.nih.gov/mesh/meshhome.html)

## **Text**

Authors should use subheadings to divide the sections of their manuscript, such as Introduction, Methods, Results, Discussion, Conclusions/Implications for Practice and/or Research, References.

## **References**

The Vancouver system of referencing must be used. In the text, references should be cited using superscript Arabic numerals in the order in which they appear. If cited in tables or figure legends, number according to the first identification of the table or figure in the text.

Cite the names of all authors when there are six or fewer; when seven or more, list the first three followed by et al. Reference to unpublished data and personal communications should not appear in the list but should be cited in the text only (e.g. Smith A, 2000, unpublished data). All citations mentioned in the text, tables or figures must be listed in the reference list.

Names of journals should be abbreviated in the style used in Index Medicus.

## **Appendices**

Appendices should be placed at the end of the paper, numbered in Roman numerals and referred to in the text. If written by a person other than the author of the main text, the writer's name should be included below the title.

## **Tables**

Tables should be self-contained and complement, but not duplicate, information contained in the text. Number tables consecutively in the text in Arabic numerals. Type tables on a separate sheet in double-spacing with the legend above. Legends should be concise but comprehensive – the table, legend and footnotes must be understandable without reference to the text. Vertical lines should not be used to separate columns. Column headings should be brief, with units of measurement in parentheses; all abbreviations must be defined in footnotes. Footnote symbols: †, ‡, §, , should be used (in that order) and \*, \*\*, \*\*\* should be reserved for P-values. Statistical measures such as SD or SEM should be identified in the headings. If tables have been reproduced from another source, a letter from the copyright holder, stating authorisation to reproduce the table, must be sent to the Editorial Office with the manuscript.

## **Figures**

All illustrations (line drawings and photographs) are classified as figures. Figures should be cited in consecutive order in the text. Line figures should be supplied as sharp, black and white graphs or diagrams, drawn professionally or with a computer graphics package; lettering must be included and should be sized to be no larger than the library text. Photographs need to be cropped sufficiently to prevent human subjects being recognised (or an eye bar should be used). Magnifications should be indicated using a scale bar on the illustration. Graphics must be supplied as high-resolution (at least 300 d.p.i.) files, saved as .eps or .tif. Digital images supplied only as low-resolution printouts and/or files cannot be used. ## **Figure legends**

Legends should be concise but comprehensive – the figure and its legend must be understandable without reference to the text. Include definitions of any symbols used and define/explain all abbreviations and units of measurement. If figures have been reproduced from another source, a letter from the copyright holder, stating authorisation to reproduce the figure, must be sent to the Editorial Office with the manuscript.

## **Proofs**

It is essential that authors supply an email address to which proofs can be emailed. A PDF (Portable Document Format) will then be sent via email as a final check of the layout, tables and figures. Alterations (other than the essential correction of errors) are unacceptable at PDF stage. Acrobat Reader is required to read the PDF.
